

How much energy storage will China have by 2025?

Many Chinese provinces have set energy storage targets since 2021. As shown in the graph below, some provinces will see nearly 100 GW of installed ESS capacity by 2025. More provincial governments introduced regulations for the generation side, the grid side, and the end user side.

What is user-side energy storage?

User-side energy storage can not only absorb renewable energy such as solar energy, but also maintain a stable power supply for houses. Through shared energy storage and other energy storage business models, the application scope of energy storage on the power generation side, transmission and distribution side, and user side will be blurred. And many application scenarios can realize the composite utilization of energy storage according to demand.
