To better understand the distinction, consider a practical scenario: Two power banks, one rated at 10,000 mAh and 3.7 volts, and another at 5,000 mAh and 7.4 volts. Despite the difference in mAh, both have the same energy capacity when you calculate their mWh ( $10,000 \text{ mAh} \times 3.7\text{V} = 37,000 \text{ mWh}$  and  $5,000 \text{ mAh} \times 7.4\text{V} = 37,000 \text{ mWh}$ ).

Milan-based battery storage developer ACL Energy has recently announced a joint venture partnership with large-scale operator BW ESS and Penso Power, a London-based developer of grid-scale battery storage assets, for developing storage projects in Italy.

Eligibility is restricted to applicants (or the shareholders of applicants), which prove equity on their balance sheets of more than BGN 6 million for battery storage projects between 20 MWh and 50 MWh and BGN 10 million for projects above 50 MWh. Each application should secure a 3% bid bond based on the amount of the grant requested.
