

How is electricity regulated in Botswana?

Electricity is regulated through the BERA Act of 2016 in conjunction with the Electricity Supply Act and the Botswana Power Corporation Act. And covers generation, transmission, distribution and sale of electricity.

What is the main source of electricity in Botswana?

Coal is the main source of electricity generation in the country, followed by diesel. However, Botswana has ample renewable energy potential to augment generation from coal. Currently, solar energy contributes insignificantly to electricity generation despite the abundance of the resource.

Can Botswana generate electricity from coal?

However, Botswana has ample renewable energy potential to augment generation from coal. Currently, solar energy contributes insignificantly to electricity generation despite the abundance of the resource. There is also wind and coal bed methane potential which have not been fully explored.

How much electricity does Botswana need?

The current electricity demand stands at 600 MW and is expected to reach 936 MW by 2025. Currently, the installed generation capacity for Botswana stands at 732 MW from coal and 160 MW from diesel peaking plants, even though the country is still faced with shortages of electric power.

How can we improve energy production in Botswana?

The use of livestock residues (cow-dung) seems to offer the highest practical opportunity for energy production in Botswana, while municipal solid waste (MSW) can also contribute to the improvement of energy generation, especially at the city level.

How will the energy sector evolve in Botswana?

This NEP acknowledges that any future developments in the energy sector of Botswana will be shaped by the realities of the past development performances of the sector, the availability of energy resources and the global context within which the government operates. On this note, 20 Policy Statements have been crafted in this regard.

Yet for thermal energy storage and CAES, the energy-related costs are much lower than they are for flow batteries, and BNEF said the latter may be better suited for mid-duration applications (which it defined as up to around 12-hour duration of discharge) than their thermal and mechanical counterparts.
