

What safety standards affect the design and installation of ESS?

As shown in Fig. 3, many safety C&S affect the design and installation of ESS. One of the key product standards that covers the full system is the UL9540 Standard for Safety: Energy Storage Systems and Equipment. Here, we discuss this standard in detail; some of the remaining challenges are discussed in the next section.

Are energy storage codes & standards needed?

Discussions with industry professionals indicate a significant need for standards..." [1, p. 30]. Under this strategic driver, a portion of DOE-funded energy storage research and development (R&D) is directed to actively work with industry to fill energy storage Codes & Standards (C&S) gaps.
