Can co-firing power plants decarbonize coal-dominant energy systems?

Coal-biomass co-firing power plants with retrofitted carbon capture and storage are seen as a promising decarbonization solution of coal-dominant energy systems. Framework with spatially explicit biomass sources, plants and geological storage sites demonstrate its effectiveness in China.

How does molten-salt energy storage affect the performance of coal-fired units?

The incorporation of molten-salt energy storage enables the decoupling of the boiler from the turbine, thus enabling the regulation of the output power during low-load operation. And the impact of key parameters on the performance of coal-fired units is analyzed to find the suitable operation parameters for the existing coal-fired power plant.

Can coal storage be replicated in other coal-fired power plants?

The study could be replicated in other coal-fired power plants. From the investigation of potential geological reservoirs for CO 2 storage in the study area, coal layers of the Rio Bonito Formation are defined as the most prospective, with a theoretical capacity to store up to 38 GtCO 2 (upper limit).

How many coal-fired power plants are eligible for cbeccs retrofitting?

Given the accessibility of available biomass, CO 2 storage sites and the potential for being along the transport pipeline network, the number of coal-fired power plants eligible for CBECCS retrofitting further narrows to 533,431 and 285 candidate plants, respectively (Fig. 1b).

How long will China's coal-fired power plants last?

At present,more than 80% of China's coal-fired power plants have been operational for less than 15 years 3; by design,they are anticipated to continue running and lock in their associated CO 2 emissions for several decades.

Will large-scale energy storage infrastructure provide a pathway to renewable power?

In addition, despite rapid technological advancements, large-scale energy storage infrastructure is still costly and hence unlikely to provide in the short/mid-term a pathway for exclusive reliance on renewable power in the transition to a sustainable, low carbon electricity sector.
