

How many carbon storage projects were selected?

Sixteen projects were selected for negotiation to support the development of new and expanded large-scale, commercial carbon storage projects, each with the capacity to securely store 50 or more million metric tons of carbon dioxide over a 30-year period.

Why is carbon storage funding important?

"The funding announced today will help ensure that carbon storage projects--crucial to slashing harmful carbon pollution--are designed, built, and operated safely and responsibly across all phases of development, to deliver healthier communities as well as high-quality American jobs." What is the DOE carbon transport & storage program?

The aspects of this funding opportunity that have been the most successful in achieving the DOE Carbon Transport and Storage Program's stated vision of "support [ing] rapid deployment of carbon storage necessary to enable the decarbonization of the U.S. economy."

Where will CO₂ be stored?

Colorado School of Mines (Golden, CO) will conduct a feasibility study to advance a carbon storage reservoir in the Sacramento Delta. Commonwealth of Virginia Department of Energy (Big Stone Gap, VA) will study a storage hub in Wise County, Virginia to store CO₂ from surrounding industrial sources.

Where is the CO₂ storage hub located?

Advanced Resources International, Inc. (Arlington, VA) will develop a commercial-scale geologic CO₂ storage hub in state waters near Monkey Island, Louisiana.
