China aims to further develop its new energy storage capacity, which is expected to advance from the initial stage of commercialization to large-scale development by 2025, with an installed capacity of more than 30 million kilowatts, regulators said.

In 2022, China's cumulative installed NTESS capacity exceeded 13.1 GW, with lithium-ion batteries accounting for 94% (equivalent to 28.7% of total global capacity). China is positioning energy storage as a core technology for achieving peak CO2 emissions by 2030 and carbon neutrality by 2060.

However, China's energy storage is developing rapidly. The government requires that some new units must be equipped with energy storage systems. How many energy storage companies are there in China?

At present, there are nearly 90,000 registered enterprises involved in the energy storage industry, data from the China Industrial Association of Power Sources (CIAPS) showed. According to the National Energy Administration, China's energy storage sector, hydropower storage excluded, will enter the stage of large-scale development in 2025.
