## China-europe energy storage planning policy

Can China develop energy storage technology and industry development?

Under the direction of the national "Guiding Opinions on Promoting Energy Storage Technology and Industry Development" policy, the development of energy storage in China over the past five years has entered the fast track.

How does the European Union affect energy storage?

Simultaneously,the European Union has made regular revisions to top-level policies and power market regulations to promote large-scale energy storage developmentand provide favorable conditions for energy storage to participate in the power market on a greater scale, which is instructive for China.

Is China's energy storage industry ready for industrialization?

While it is true that the development of China's energy storage industry has moved from a technical verification stage to a new stage of early commercialization, the industry still faces many challenges which hinder development, and true " industrialization " has not yet materialized.

What does the European Commission say about energy storage?

The Commission adopted in March 2023 a list of recommendations to ensure greater deployment of energy storage, accompanied by a staff working document, providing an outlook of the EU's current regulatory, market, and financing framework for storage and identifies barriers, opportunities and best practices for its development and deployment.

How big is China's energy storage capacity?

According to CNESA data, the capacity of independent energy storage stations planned or under construction in China in the first half of 2022 was 45.3GW, accounting for over 80% of all new energy storage projects planned or under construction.

Is China in a 'critical stage' of ensuring energy security?

The Hong Kong-based South China Morning Post focused on the plan's wording that China is in a "critical stage" of ensuring energy security when new and old risks become "intertwined". Shanghai-based Sixth Tone reported that China "seeks to minimise its reliance on fossil fuels and adopt more forms of renewable energy".
