What are energy storage specific project requirements?

Project Specific Requirements: Elements for developing energy storage specific project requirements include ownership of the storage asset, energy storage system (ESS) performance, communication and control system requirements, site requirements and availability, local constraints, and safety requirements.

What are the safety requirements for energy storage technologies?

Safety: Minimum safety and operating requirements are common considerations for energy projects. Energy storage resources present additional safety concerns given their unique technological profiles. For battery storage technologies in particular, safety requirements should adequately address fire risks.

Do energy storage systems need a CSR?

Until existing model codes and standards are updated or new ones developed and then adopted, one seeking to deploy energy storage technologies or needing to verify an installation's safety may be challenged in applying current CSRs to an energy storage system (ESS).

What are the components of energy storage systems?

System components consist of batteries, power conversion system, transformer, switchgear, and monitoring and control. A proper economic analysis identifies the costs associated with each of these components. Source: EPRI. Understanding the components of energy storage systems is a critical first step to understanding energy storage economics.
