Does Colombia have a power purchase agreement for hybrid solar & Bess projects?

As of now, Colombia's reliability charge (Cargo por Confiabilidad) has encouraged hybrid solar +BESS projects to progress. Large energy companies have expressed that there are no Power Purchasing Agreements (PPAs) available specifically for stand-alone storage projects, making it harder to finance those projects.

How does the IEA support Colombia's energy transition?

The IEA supports Colombia's agenda for a just energy transition. Experience from the IEA's Global Commission on People-Centred Transitionsprovides useful learnings for the government of Colombia, helping to boost local economic benefits and the transition to clean energy and new job opportunities.

Can Colombia diversify into new minerals?

Colombia can build on its well-established mining sectorto diversify into new minerals. To reap this potential, mining activities must adhere to high environmental, social and governance standards and generate tangible benefits for affected local communities. Security of supply should be a priority for the government during the transition.

Does Colombia have a natural resource base?

Colombia enjoys a strong natural resource base. Renewables accounted for more than a third of total final energy consumption in 2020, thanks to the significant role of conventional hydropower and bioenergy.

Does Colombia have a hydrogen-to-power market?

Hydrogen-to-power strategies are key to decarbonisation pathways in Europe and Asia,making these key potential export markets for hydrogen produced in Colombia. We estimate the levelised cost of hydrogen (LCOH) in Colombia could be similar to Chile's.

Does Colombia have a decarbonised power sector?

Colombia has a largely decarbonised power sectorthanks to the significant role of hydropower and bioenergy. Electricity demand is expected to increase as a result of economic growth and the electrification of end-use sectors, an opportunity to decarbonise the transport sector over time.
