How much power does T&#252;rkiye generate?

T&#252;rkiye generated 118 TWh of power from coal, ahead of Poland's 97 TWh and almost reaching Germany's 121 TWh. In 2013, 25% of power was from coal in both T&#252;rkiye and the EU. In 2023, this was down to a record low 12% in the EU, but reached a record high 36% in T&#252;rkiye. The rise in coal-fired electricity generation was driven by imported coal.

How much electricity is generated by natural gas in T&#252;rkiye?

Thus, the share of electricity generation from natural gas in total generation fell to 16% in December - the lowest level in December for five years. Although T&#252;rkiye has added 11 GW of wind and solar capacity in the last five years, other European countries have proved this is possible in a single year.
