Eurowind Energy merged with Eniig Renewables in 2019, enabling the company to grow even further. It expanded its activities into the UK in 2019 and acquired the German wind developer, Windenergie Wenger-Rosenau GmbH & Co. KG, in the same year.

Which wind energy companies have been acquired in the UK?

It expanded its activities into the UK in 2019 and acquired the German wind developer, Windenergie Wenger-Rosenau GmbH & Co. KG, in the same year. It also acquired SE Blue Renewables from PFA and Norlys, which then had 184 MW in operation, and the Overgaard Wind Park project, consisting of 26 wind turbines.
