

What is decentralisation in France?

The French Constitution of 1958 identifies decentralisation as the organisational model of the Republic.<sup>1</sup> While guaranteed by the fundamental law, decentralisation is still subject to debates, discussions and reforms.<sup>2</sup> Moreover, in France, the introduction of decentralisation is rather recent insofar as it was recognised barely 30 years ago.

How did decentralisation become a basic principle of the French state?

Three fundamental pieces of legislation made decentralisation a basic principle of the French State. First of all, the constitutional Law of 28 March 2003<sup>11</sup> established the principle of decentralisation as an organisational mode of the Republic (Article 1 of the Constitution of 1958).

How does the French government deal with decentralization?

In addition to a general central government block grant (dotation specifically designed to compensate for new policy responsibilities under decentralization), their responsibilities in education and to cover investment items. When did decentralisation start in France?

In France, the policy of decentralisation was initiated by acts of the French Parliament known as Gaston Defferre laws in 1982. Prior to the new laws French municipalities and departments enjoyed a limited autonomy under laws passed in 1871 and 1884.

Is France a decentralised unitary state?

France has been a decentralised unitary state since 1982. The process has been slowly advancing with a very particular mind-set on the part of the public authorities: the emergence of the local authorities took place against the central state and was not considered a pertinent mode of public action management.
