What is the Eswatini Energy Programme?

There is no simplified licensing framework for off-grid and small systems.

Legal Mandate ESERA was established by an act of parliament, the Energy Regulatory Act, 2007, which gives it the statutory right to regulate the electric power industry in Eswatini. The establishment of ESERA by legislation enhances the credibility of the institution and is likely to have a positive impact on investor and consumer confidence.
