## **Energy storage financing leasing software**

Why do energy storage projects need project financing?

The rapid growth in the energy storage marketis similarly driving demand for project financing. The general principles of project finance that apply to the financing of solar and wind projects also apply to energy storage projects.

Can you finance a solar energy storage project?

Since the majority of solar projects currently under construction include a storage system, lenders in the project finance markets are willing to financethe construction and cashflows of an energy storage project. However, there are certain additional considerations in structuring a project finance transaction for an energy storage project.

3.3. Energy Management Software Energy management software has emerged as the most critical aspect of achieving successful energy system operation(assuming of course a well-designed and capable energy storage technology) for individual systems and fleets of units in a portfolio.

Are energy storage projects different than power industry project finance?

Most groups involved with project development usually agree that energy storage projects are not necessarily differentthan a typical power industry project finance transaction, especially with regards to risk allocation.

Will a tax credit be available for energy storage projects?

However, with the passage of the Inflation Reduction Act of 2022, tax credits are now available for standalone energy storage systems, and thus lenders may be willing to provide bridge capital that is underwritten based on the receipt of proceeds from an anticipated tax equity investment, similar to renewable energy projects.

Is there a database for energy storage projects?

There are a number of proprietary energy storage project databases on the market, but the U.S. Department of Energy has provided a publicly available database on projects operating across the globe, establishing a basis for improving pricing visibility for energy storage projects.
