What is an energy storage system?

Powering the Future: Safeguarding Today with Energy Storage Systems According to the National Fire Protection Association (NFPA), an energy storage system (ESS), is a device or group of devices assembled together, capable of storing energy in order to supply electrical energy at a later time.

Are battery storage fires igniting?

The number of installations is on the rise, but a persistent problem keeps coming up -- fires igniting at battery storage facilities. Most recently, a fire broke out at the Valley Center Energy Storage Facility in San Diego County on Sept. 18.

What happened to SDG&E energy storage facility?

Located on seven acres in a commercial-industrial zone, the facility opened in February 2022 and delivers energy to a nearby SDG&E substation. The Sept. 18 fire is under investigation, with fire officials saying they expect a final determination coming in about two months. The storage facility resumed operations the following day.

What is a battery energy storage system (BESS)?

There has been a dramatic increase in the use of battery energy storage systems (BESS) in the United States. These systems are used in residential, commercial, and utility scale applications. Most of these systems consist of multiple lithium-ion battery cells. A single battery cell (7 x 5 x 2 inches) can store 350 Whr of energy.
