How can energy storage help the electric grid?

Three distinct yet interlinked dimensions can illustrate energy storage's expanding role in the current and future electric grid--renewable energy integration, grid optimization, and electrification and decentralization support.

How long does a grid need to store electricity?

First,our results suggest to industry and grid planners that the cost-effective duration for storage is closely tied to the grid's generation mix. Solar-dominant grids tend to need 6-to-8-hstorage while wind-dominant grids have a greater need for 10-to-20-h storage.

Which technologies are commercially available for grid storage?

Several technologies are commercially available or will likely be commercially available for grid storage in the near-term. The technologies evaluated provide storage durations that range from hours to days and response times of milliseconds to minutes. Four families of battery technologies and three LDES technologies are evaluated.

Will energy storage change the dynamics of a grid?

With widespread grid failures on this scale, energy storage would have to make up a much larger share of system capacity than it currently does to change the dynamics, although it can respond to sudden system fluctuations by providing ancillary services, like frequency and voltage regulation.

How is energy and power capacity optimized in a candidate storage plant?

Energy and power capacity of candidate storage plants are unconstrained and optimized by the model from the perspective of the grid, such that the model may build storage of any duration and size in each load zone.

Should electric power companies deploy decentralized storage assets?

Storage as an equity asset: By deploying decentralized storage assets, electric power companies can help provide reliable, resilient, clean, and affordable electricity to low-income communities.
