What's going on with Arizona's energy storage explosion?

The explosion in Arizona comes at a sensitive time for the fledgling storage industry, with a number of U.S. states moving to make storage central to their grid planning. Arizona utility APS has grounded its energy storage operations while the investigation continues.

What causes large-scale lithium-ion energy storage battery fires?

Conclusions Several large-scale lithium-ion energy storage battery fire incidents have involved explosions. The large explosion incidents, in which battery system enclosures are damaged, are due to the deflagration of accumulated flammable gases generated during cell thermal runaways within one or more modules.

What happened at McMicken energy storage unit?

This incident occurred at the Arizona Public Service (APS, 2019) McMicken Energy Storage Unit facility in Surprise, Arizona, 28 miles northwest of Phoenix. As shown in Fig. 3, the facility is adjacent to an APS substation. It is a 2 MW, 2 MWh facility with 27 racks, each containing 392 Li-ion Nickel-Manganese-Cobalt pouch cells (DNV GL, 2020).

Will energy storage grow in the future?

Projections about the future growth of energy storage are eye-opening. For context, consider that the U.S. Energy Information Administration (EIA) reported that 402 megawatts of small-scale battery storage and just over one gigawatt of large-scale battery storage were in operation in the United States at the end of 2019.

What is the maximum temperature induced by an explosion?

In the accident building,the explosion overpressure generated at the end of the barrier path exceeded 70 kPa,and the intense development of the explosion flame between the barriers resulted in a maximum temperature of over 2038 K.
