Should Iraq rely on state financing for energy projects?

There has scarcely been a more urgent time for Iraq to pursue crucial reforms in its energy sector to ensure that investment continues even when government revenues have been decimated by low oil prices. The alternative of continuing to rely on direct state financing of large projects only increases the risk that these projects are delayed.

Should Iraq invest in renewables?

Integrating renewables requires a large investment in grids, and Iraq's transmission and distribution networks are already dilapidated, with electricity dues largely uncollected, giving rise to technical and commercial losses that exceed 50% of generated power. Adding intermittent solar generation will be a novel challenge.

Does Iraq have an integrated national energy strategy?

Since 2012,Iraq had added one-in-every five barrels of global incremental oil supplies,but has failed to implement its own Integrated National Energy Strategyfirst by disintegrating gas and oil development and second by missing on gas-to-power synergies.
