

What is the energy storage standard?

The Standard covers a comprehensive review of energy storage systems, covering charging and discharging, protection, control, communication between devices, fluids movement and other aspects.

Does industry need standards for energy storage?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].

What is the energy storage protocol?

The protocol is serving as a resource for development of U.S. standards and has been formatted for consideration by IEC Technical Committee 120 on energy storage systems. Without this document, committees developing standards would have to start from scratch. WHAT'S NEXT FOR PERFORMANCE?

Does energy storage need C&S?

Energy storage has made massive gains in adoption in the United States and globally, exceeding a gigawatt of battery-based ESSs added over the last decade. While a lack of C&S for energy storage remains a barrier to even higher adoption, advances have been made and efforts continue to fill remaining gaps in codes and standards.

What are the goals of the energy storage safety workshop?

The goals of the workshop were to: 1) bring together all of the key stakeholders in the energy storage community, 2) share knowledge on safety validation, commissioning, and operations, and 3) identify the current gaps in understanding, managing, standardizing and validating safety in energy storage systems.

Should energy storage safety test information be disseminated?

Another long-term benefit of disseminating safety test information could be baselining minimum safety metrics related to gas evolution and related risk limits for creation of a pass/fail criteria for energy storage safety testing and certification processes, including UL 9540A.
