The Sept. 18 fire is under investigation, with fire officials saying they expect a final determination coming in about two months. The storage facility resumed operations the following day.

What happened at Gateway Energy Storage in San Diego?

The firebroke out on Wednesday at the 250MW Gateway Energy Storage facility owned by grid infrastructure developer LS Power in San Diego. A fire crew managed to get the blaze at the 16,000-square foot facility under control after around 24 hours, lifting evacuation orders that were made.
