What are the different types of energy storage policy?

Approximately 16 states have adopted some form of energy storage policy, which broadly fall into the following categories: procurement targets, regulatory adaption, demonstration programs, financial incentives, and consumer protections. Below we give an overview of each of these energy storage policy categories.

Do states need a new energy storage policy?

As states increasingly declare decarbonization goals, they will need to create new policies, rules and regulations that will enable the deployment of an unprecedented amount of energy storage, according to the Clean Energy States Alliance (CESA), which just released its States Energy Storage Policy: Best Practices for Decarbonization report.

Do you need a solar energy storage system?

Now, energy storage devices that have a capacity rating of 3 kilowatt hours or greater are included. This includes stand-alone storage, but here's why you should pair it with solar. The ITC will cut the cost of installing rooftop solar for a home by 30%, or more than \$\&\pm\$160;\$7,500 \$\&\pm\$160;for an average system.

Does state energy storage support decarbonization?

Which states have set policy for energy storage deployment?

California and New York are cited as examples of states with "very advanced and sophisticated policy measures". Many others are beginning to assess energy storage policy needs.
