What is the future of energy storage?

Storage enables electricity systems to remain in balance despite variations in wind and solar availability, allowing for cost-effective deep decarbonization while maintaining reliability. What is the energy storage roadmap?

First established in 2020 and founded on EPRI's mission of advancing safe, reliable, affordable, and clean energy for society, the Energy Storage Roadmap envisioned a desired future for energy storage applications and industry practices in 2025 and identified the challenges in realizing that vision.

Is India ready for battery energy storage in 2022?

The Inflation Reduction Act, passed in August 2022, includes an investment tax credit for stand-alone storage, promising to further boost deployments in the future. In its draft national electricity plan, released in September 2022, India has included ambitious targets for the development of battery energy storage.
