## What is the 'guidance' for the energy storage industry?

Based on the above analysis, as the first comprehensive policy document for the energy storage industry during the '14th Five-Year Plan' period, the 'Guidance' provided reassurance for the development of the industry.

What is the 'guidance on accelerating the development of new energy storage?

Since April 21,2021,the National Development and Reform Commission and the National Energy Administration have issued the 'Guidance on Accelerating the Development of New Energy Storage (Draft for Solicitation of Comments)' (referred to as the 'Guidance'),which has given rise to the energy storage industry and even the energy industry.

What grants are available under the long-duration energy storage program?

Other awards approved under the Long-Duration Energy Storage Program include: \$31 million for a 60 MW renewable backup power microgrid in San Diego County. \$32 million for a 20 MW microgrid project in Tehama County. The grants are two of the largest the state has ever awarded to benefit California Native American tribes.

Will energy storage eliminate industrial development?

In the context of the 'dual-carbon' goal and energy transition, the energy storage industry's leapfrog development is the general trend and demand. The follow-up actions will inevitably introduce a series of policies for the development of energy storage to eliminate industrial development. Faced with 'obstacles' one by one.

Why did the energy industry release the 'guidance'?

The industry has given a high degree of recognition to the release of the Guidance and positive feedback. On July 23, the National Development and Reform Commission and the National Energy Administration formally issued the "Guidance" after fully soliciting suggestions from all walks of life.

What is the long-duration energy storage Award?

The award is one of three approved under the CEC's Long-Duration Energy Storage program, which is part of Governor Gavin Newsom's historic multi-billion-dollar commitment to combat climate change. The program invests in demonstration of non-lithium-ion technologies across the state to create a diverse portfolio of energy storage technologies.
