

Why was the energy storage roadmap updated in 2022?

The Energy Storage Roadmap was reviewed and updated in 2022 to refine the envisioned future states and provide more comprehensive assessments and descriptions of the progress needed (i.e., gaps) to achieve the desired 2025 vision.

Will China install 30 GW of energy storage by 2025?

In July 2021 China announced plans to install over 30 GW of energy storage by 2025 (excluding pumped-storage hydropower), a more than three-fold increase on its installed capacity as of 2022.

Energy storage is essential to a clean and modern electricity grid and is positioned to enable the ambitious goals for renewable energy and power system resilience.

How did energy storage grow in 2022 & 2023?

The US utility-scale storage sector saw tremendous growth over 2022 and 2023. The volume of energy storage installations in the United States in 2022 totaled 11,976 megawatt hours (MWh)--a figure surpassed in the first three quarters of 2023 when installations hit 13,518 MWh by cumulative volume.

How many states have energy storage policies?

Around 15 states have adopted some form of energy storage policy, including procurement targets, regulatory adaption, demonstration programs, financial incentives, and/or consumer protections. Several states have also required that utility resource plans include energy storage.

How much battery storage will the United States use in 2022?

As of October 2022, 7.8 GW of utility-scale battery storage was operating in the United States; developers and power plant operators expect to be using 1.4 GW more battery capacity by the end of the year. From 2023 to 2025, they expect to add another 20.8 GW of battery storage capacity.

1 ¶ In 2025, some 80 gigawatts (gw) of new grid-scale energy storage will be added globally, an eight-fold increase from 2021. Grid-scale energy storage is on the rise thanks to four potent forces.
