

What are battery energy storage systems?

Battery Energy Storage Systems are electrochemical type storage systems defined by discharging stored chemical energy in active materials through oxidation-reduction to produce electrical energy. Typically, battery storage technologies are constructed via a cathode, anode, and electrolyte.

What are commercial energy storage products?
