Can a large-scale solar battery energy storage system improve accident prevention and mitigation?

This work describes an improved risk assessment approach for analyzing safety designs in the battery energy storage system incorporated in large-scale solar to improve accident prevention and mitigation, via incorporating probabilistic event tree and systems theoretic analysis. The causal factors and mitigation measures are presented.

What's new in energy storage safety?

Since the publication of the first Energy Storage Safety Strategic Plan in 2014, there have been introductions of new technologies, new use cases, and new codes, standards, regulations, and testing methods. Additionally, failures in deployed energy storage systems (ESS) have led to new emergency response best practices.

Are there safety gaps in energy storage?

Table 6. Energy storage safety gaps identified in 2014 and 2023. Several gap areas were identified for validated safety and reliability, with an emphasis on Li-ion system design and operation but a recognition that significant research is needed to identify the risks of emerging technologies.

Are grid-scale battery energy storage systems safe?

Despite widely known hazards and safety design of grid-scale battery energy storage systems, there is a lack of established risk management schemes and models compared to the chemical, aviation, nuclear and the petroleum industry.

Can energy storage systems be scaled up?

The energy storage system can be scaled up by adding more flywheels. Flywheels are not generally attractive for large-scale grid support services that require many kWh or MWh of energy storage because of the cost,safety,and space requirements. The most prominent safety issue in flywheels is failure of the rotor while it is rotating.

What are the three pillars of energy storage safety?

A framework is provided for evaluating issues in emerging electrochemical energy storage technologies. The report concludes with the identification of priorities for advancement of the three pillars of energy storage safety: 1) science-based safety validation,2) incident preparedness and response,3) codes and standards.
