Energy generation in Zambia relies almost entirely on hydro power,accounting for nearly 90 percent of its total installed generation capacity.

Zambia has also realized the need to diversify its energy sources through increased use of solar energy. It has implemented two utility-scale solar power plants (54 megawatts and 34 megawatts) in Lusaka south multi-facility economic zone under the World Bank Scaling Solar initiative ,.

Energy generation in Zambia relies almost entirely on hydro power,accounting for nearly 90 percent of its total installed generation capacity. While the country's electrification rate stands at approximately 27.9 percent,it is facing a serious electricity supply deficit from recent droughts.

For German and European service providers active in the energy sector,Zambia presents significant potential for business development. There are clear needs across the solar energy and storage value chain,including pro-ject development and financing,equipment manufacturing,system inte-gration and contracting.

How can solar mini-grids improve sustainability in Zambia?

Therefore in order to improve sustainability, a multi-dimensional approach is needed. Currently, operators of solar mini-grid in Zambia include government or government agencies such as the Rural Electrification Authority (REA), the National Technology and Business Council (NTBC), community/cooperatives, or private investors.
