EnerSys is the industrial technology leader serving the global community with mission critical stored energy solutions that meet the growing need for energy efficiency, reliability and sustainability.

What does EnerSys do?

EnerSys is a stored energy systems and technology provider for industrial applications. The company manufactures reserve power and motive power batteries, battery chargers, power equipment, battery accessories and outdoor equipment enclosure systems.

Does EnerSys sell batteries?

EnerSys also manufactures and sells related DC power products including chargers, electronic power equipment and a wide variety of battery accessories. Their battery products cover a broad range of sizes, configurations and electrical capabilities. EnerSys, in 2000, acquired Yuasa's industrial division. The Hawker Group merged with EnerSys in 2002.

Who is the CEO of EnerSys?

The president and CEO as of 2024 is David M. Shaffer. EnerSys produces reserve power batteries, marketed and sold principally under the Alpha, PowerSafe, DataSafe, Hawker, Genesis, ODYSSEY and CYCLON brands.

How does EnerSys maintain its leadership position?

EnerSys maintains its leadership position by providing customers with world-class products and services, achieved through total employee involvement, teamwork and supplier partnerships. Exceeding customer expectations and supplying the highest quality products and services are paramount at EnerSys.

What industries did EnerSys acquire?
