Are hybrid minigrids a viable option for centralized hydroelectric power plants in Ethiopia?

The landform and scattered population in Ethiopia, especially in rural areas, makes the centralized hydroelectric power plants challenging and costly (Seboka, 2017). The construction of hybrid minigrids is considered as an effective method. Government of Ethiopia (GOE) is now diversifying the generation mix with other renewable sources.

How many diesel-based minigrids are there in Ethiopia?

The implementation of minigrid projects is currently underway with support from the World Bank and collaboration with industrial partners. Within this initiative,36diesel-based minigrids have been established by the Ethiopian Electric Utility (EEU), with approximately 35% of them boasting a capacity of 100 kW.

Grid integration studies fall into three general categories: capacity expansion, production cost, and power flow studies, as summarized in Table 1. The choice of which study to implement depends on . the questions that are most applicable to a power system's context and priorities.

Ethiopia has connected 33% of its population to the national grid and 11% with off-grid solutions--mostly mini-grids and solar PV systems. Since 2012, wind farms have been installed to compensate for the shortfalls of hydroelectric power in the dry season, but wind energy remains marginal in the national energy mix [63].

Note that a grid integration study is not the same as a grid impact or grid connection study, which focus on the technical feasibility of interconnecting a single wind or solar power plant. When to Conduct a Grid Integration Study. A grid integration study is a substantial undertaking that can take several months to a few years to complete.
