What does the European Commission say about energy storage?

The Commission adopted in March 2023 a list of recommendations to ensure greater deployment of energy storage, accompanied by a staff working document, providing an outlook of the EU's current regulatory, market, and financing framework for storage and identifies barriers, opportunities and best practices for its development and deployment.

Why is energy storage important in the EU?

The EU has a comprehensive database of the European energy storage technologies and facilities. Energy storage also plays an important role in the European Green Deal and the Fit for 55 green transition package, a set of policy initiatives aiming at ensuring the EU gradually becomes climate neutral.

Is energy storage the key to decarbonising the EU energy system?

The Commission has published today a series of recommendations on energy storage, with concrete actions that EU countries can take to ensure its greater deployment. Analysis has shown that storage is key to decarbonising the EU energy system.

How much gas is stored in the EU?

Gas storage in the EU is now at more than 90%. It was 30% in February 2022, and since then we have been working with EU countries to increase Europe's energy reserves In order to secure the EU's energy supply at affordable prices, the Commission and the Member States have established an EU Platform for the common purchase of gas, LNG and hydrogen.

Which country has the largest energy storage system in Europe?

United KingdomThe UK is a leader in Europe with respect to energy storage projects. Harmony Energy Ltd.'s battery energy storage system (BESS), which went live in the United Kingdom in November 2022, was reported to be Europe's largest BESS in megawatt hours (MWh) so far.
