## Export requirements for energy storage batteries

What are battery safety requirements?

These include performance and durability requirements for industrial batteries, electric vehicle (EV) batteries, and light means of transport (LMT) batteries; safety standards for stationary battery energy storage systems (SBESS); and information requirements on SOH and expected lifetime.

What are the requirements for a rechargeable industrial battery?

Performance and Durability Requirements (Article 10) Article 10 of the regulation mandates that from 18 August 2024,rechargeable industrial batteries with a capacity exceeding 2 kWh,LMT batteries,and EV batteries must be accompanied by detailed technical documentation.

When do I need to submit technical documentation for a stationary battery energy storage system? Safety of Stationary Battery Energy Storage Systems (Article 12) Technical documentation demonstrating successful testing for the safety parameters listed in Annex V of the regulation must be submitted by 18 August 2024.

How much recycled content should a battery have?

The regulation provides for mandatory minimum levels of recycled content for industrial, SLI batteries and EV batteries. These are initially set at 16% for cobalt, 85% for lead, 6% for lithium and 6% for nickel. Batteries will have to hold a recycled content documentation.
