

Who are Masdar & Taaleri Energia?

Why is Masdar launching a hybrid solar and wind project?

They represent a significant expansion in Masdar's growing European portfolio. By developing hybrid PV solar and wind projects, Masdar is capitalizing on recent amendments to the Polish Energy Law, known as Cable Pooling, which allow for the linking of different renewable energy sources in a single grid connection.

What is Masdar doing in Poland?
