While around 254 terawatt-hours (TWh) of electricity were generated from renewable energy in Germany in 2022,600 TWh of electricity are expected to come from renewable sources by 2030. Will Germany guarantee minimum gas storage levels?

FRANKFURT, April 22 (Reuters) - A bill to guarantee minimum gas storage levels in Germany, whose underground facilities account for a quarter of the EU bloc's total capacity, will kick in from May 1 after parliamentary approval.

Is gas storage a pillar of a secure energy system?

Gas storage is a cornerstone of the energy infrastructure in Europe. When demand peaks on cold winter days, up to 60 per cent of Germany's gas supply is provided by gas storage facilities. Looking at future storage needs for renewable energies, however, gas storage will also be a necessary pillar of a secure energy system in the future.

How big is the energy storage industry in Germany?

With a turnover of over 15.7 billion euros, and a 46 percent growth increase in comparison to 2022, the energy storage sector's expansion in Germany continues at a fast pace, according to industry data released by the German Association of Energy Storage Systems (BVES).

Are German gas storage facilities full?

Despite the suspension of gas deliveries from Russia at the end of August, German gas storage facilities are now more than 90 percent full, according to data published by European storage operators. Storage facilities in the country reached a level of nearly 91 percent last Sunday.

Is supply security guaranteed in Germany?

"Supply security in Germany currently is guaranteed," a spokesperson said, following an announcement by Ukraine's gas pipeline operator that it would redirect some gas flows from Russia to Europe due to "force majeure" imposed by the Russian occupation of Ukrainian territory.
