Can I ship un3481 & un3091 lithium batteries?

A: No, the updated regulation does not apply to UN3481 and UN3091 lithium batteries contained in or packed with equipment. It only applies to UN3840 and UN3090 stand-alone lithium batteries. Use the chart below to see what types of batteries you can ship as Section I, Section II, IA, and IB.

What is a lithium ion battery?

Lithium Ion Batteries or Cells. are non-rechargeable (primary) lithium metal or lithium alloy cells or batteries. These have a longer life than standard alkaline batteries or cells, and are commonly used in cameras, smoke detectors, etc. Lithium Metal Batteries or Cells. 2024 Lithium Batteries Regulations: Lithium Ion Batteries.

Does a lithium battery Mark have a UN number?

Yes. The mark may bear all applicable UN numbers, e.g. UN 3091, UN 3481, to identify that the package contains lithium metal batteries packed with or contained in equipment and lithium ion batteries packed with, or contained in equipment. J. What are the requirements for the telephone number on the lithium battery mark?

Can a lithium battery be shipped on a cargo aircraft?

Lithium Metal Batteries UN3090 Lithium Metal Cells and Batteries shipped by themselves - UN3090 (not contained in or packed with equipment) are forbidden for transport as cargo on passenger aircraft. They can be shipped on cargo aircrafts when packed in accordance with Packing Instruction 968.

What are the packaging requirements for lithium ion batteries / cells?

ACS - No requirements. UN3481,Lithium Ion Batteries /Cells - PI967 Section II. The equipment must be packed in strong rigid outer packaging. Large equipment can be offered for transport unpackaged or on pallets when the cells or batteries are afforded equivalent protection by the equipment in which they are contained.

Are lithium batteries classified in Class 9 - dangerous goods?

Lithium batteries are classified in Class 9 - Miscellaneous dangerous goodsas: or, if inside a piece of equipment or packed separately with a piece of equipment to power that equipment as: UN 3481, Lithium-ion batteries packed with equipment.
