May 23 (SeeNews) - Malaysian firm Edra Power Holdings Sdn Bhd plans to spend MYR 400 million (USD 98.2m/EUR 87.5m) to build a 50-MW solar park in the northwestern state of Kedah, news agency Bernama said on Sunday.
