## Household energy storage parameter requirements

Are energy storage codes & standards needed?

Discussions with industry professionals indicate a significant need for standards..." [1,p. 30]. Under this strategic driver, a portion of DOE-funded energy storage research and development (R&D) is directed to actively work with industry to fill energy storage Codes &Standards (C&S) gaps.

Why is energy storage important for Household PV?

However, the configuration of energy storage for household PV can significantly improve the self-consumption of PV, mitigate the impact of distributed PV grid connection on the distribution network, ensure the safe, reliable and economic operation of the power system, and have good environmental and social benefits.

Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].

What are the operational models of a home energy storage system?

The details of each of these operational models are provided in the Methods. For both operational models, three parameters define the home energy storage system: its power capacity ( Prated) in kilowatts, its energy capacity ( Erated) in kilowatt hours, and its roundtrip (a.c. to a.c.) energy efficiency ( irt ).

What is the impact of capacity configuration of energy storage system?

The capacity configuration of energy storage system has an important impact on the economy and security of PV system. Excessive capacity of energy storage system will lead to high investment, operation and maintenance costs, while too small capacity will not fully mitigate the impact of PV system on distribution network.

How to improve the economic benefits of Household PV storage system?

The government can formulate appropriate energy storage subsidies or incentive policiesto reduce the investment and operating costs of household PV storage system, so as to effectively improve the economic benefits of rural household PV storage system. Innovate and improve the market-oriented transaction mode of distributed generation.
