Significant gaps remain in the coverage of estimated subsidy levels in the energy sector.

Are inventory and price-gap a solution to total energy sector subsidy estimates?

In this respect, taken individually, both the inventory and price-gap approaches must be seen as only partial solutions arriving at total energy sector subsidy estimates, as they both have areas of weakness in terms of what subsidies they can capture.
