## Hydrogen energy storage technology standards

What is a hydrogen standards system?

The guidelines have systematically established the standards system on the full industrial chain of hydrogen energy including production, storage, transport and use, which covers five subsystems for fundamentals and safety, hydrogen preparation, hydrogen storage and transport, hydrogen filling as well as hydrogen energy application.

#### What is hydrogen storage?

Hydrogen storage is a key enabling technology for the advancement of hydrogen and fuel cell technologies in applications including stationary power, portable power, and transportation.

Is hydrogen storage a prerequisite for widespread use of hydrogen energy?

Therefore, the development of safe and economical hydrogen storage and transportation technology is an important prerequisite for the widespread use of hydrogen energy. Fig. 1 shows the cost structure of the industrial by-product hydrogen energy industry chain (see Fig. 2). Fig. 1.

How does the hydrogen storage program work?

Much of the effort of the Hydrogen Storage program is focused on developing cost-effective hydrogen storage technologies with improved energy density. Research and development efforts include high- pressure compressed storage and materials-based storage technologies.

Why is hydrogen storage and transportation important?

Among them, the cost of the storage and transportation link exceeds 30%, making it a crucial factor for the efficient and extensive application of hydrogen energy. Therefore, the development of safe and economical hydrogen storage and transportation technology is an important prerequisite for the widespread use of hydrogen energy.
