"It's an expanding pod and there's room for a lot of others, but I think we're the strongest and with BlackRock sit in a very strong position," Smith said at the time. On its 10-year anniversary in March, Vanguard announced it had achieved a network of 32 digesters and had a goal to reach 100 by 2028.
