Will Italy deploy 71 GWh of energy storage in 2033?

How much power will Italy have next year?

From ESS News Italy's latest capacity market auction for power to be delivered next year assigned 42.2 GWof capacity,data published by transmission system operator Terna showed. These include nearly 37.6 GW of existing capacity,around 233 MW of new capacity,as well as 4.36 GW of capacity from abroad.

Where will EP Produzione build a battery energy storage system?
