The European Union (EU) Commission has approved a state aid scheme aiming to fund the rollout of over 9GW/71GWh of energy storage in Italy. The scheme totalling EUR17.7 billion (US\$19.5 billion) will provide annual payments covering investment and operating costs for those developing, building and operating large-scale energy storage in Italy.

However, permitting bottlenecks remain a key concern. Figures by industry group Italia Solare put the current size of the Italian energy storage sector at approximately 450MWof total installed capacity.

How much solar storage will Italy need by 2025?

Italian transmission system operator (TSO) Terna said that 1GWof storage linked to solar farms will be needed by 2025 to help maintain system adequacy, with additional 6GW of utility-scale storage needed by 2030. The majority of revenue for storage assets comes from participation in Terna's fast reserve scheme.
