

How reliable is Japan's energy system?

The base fuel price case analysis shows that a highly dependable system is possible with 90% of Japan's electricity provided by clean energy sources, without any coal generation. This 2035 generation model is shown to operate dependably with a mix of 59% (in summer) to 72% (in winter) wind and solar energy--even during unanticipated load increases.

What are Japan's Energy plans?

Japan's 6th Strategic Energy Plan (released in 2021) and the GX (Green Transformation) Decarbonization Power Supply Bill (released in 2023) target increasing the share of non-fossil fuel generation sources to 59% of the generation mix by 2030 compared with 31% in 2022.

Is Japan's Energy Policy ambitious?

Japan's government called the package of energy policies and their targets "ambitious." Energy security considerations may affect the progress and pace of decarbonization in the electric power sector.

What is Japan's 6th Strategic Energy Plan?

According to Japan's 6th Strategic Energy Plan, battery storage will be increased as a distributed source of electricity closer to end users and within microgrids. This new policy calls for an increase in installed solar capacity from 79 gigawatts (GW) in 2022 to 108 GW by 2030.

Can Japan reduce emissions by 46% by 2030?

The country aims to reduce emissions by 46% by 2030, but it is not clear whether this medium-term target can be met under current energy policy. Japan must first accelerate the expansion of renewables in the power sector as much as possible and, in the process, phase out coal-fired and nuclear power by 2030.

What type of electricity does Japan use?

Liquefied natural gas (LNG) and coal power plants (typically fueled with coal N.E.S., a common type of coal used in Japan) still account for roughly 80% of the nation's electricity generation.
