#### What are the different types of energy storage policy?

Approximately 16 states have adopted some form of energy storage policy, which broadly fall into the following categories: procurement targets, regulatory adaption, demonstration programs, financial incentives, and consumer protections. Below we give an overview of each of these energy storage policy categories.

#### Should energy storage be co-optimized?

Storage should be co-optimizedwith clean generation, transmission systems, and strategies to reward consumers for making their electricity use more flexible. Goals that aim for zero emissions are more complex and expensive than net-zero goals that use negative emissions technologies to achieve a reduction of 100%.

#### How much storage capacity does Texas have in 2023?

At the end of 2023,Texas had 7.3 GWof installed storage capacity,while California had 3.2 GW of installed capacity. In 2022,CAISO,ERCOT,NYISO,PJM,and ISO-NE collectively had approximately 4.3 GW of standalone storage capacity, with another collective 24 GW expected to come online between 2024 and 2025.

In May 2023, Maryland became the 11th and latest state to enact an energy storage target, with a goal to deploy 3 GW of storage capacity by 2033. The new law requires the Maryland Public Service Commission to establish ...
