

How much does ACEN pay Giga Ace 8?

ACEN Corp. said Thursday it signed a subscription contract with wholly-owned subsidiary Giga Ace 8 Inc. for the additional subscription in the company amounting to P8.69 billion. ACEN said in a disclosure to the stock exchange it paid P2.174 billion as initial investment in its subsidiary.

How much is Giga Ace 8 subscription worth?

The subscribed shares are composed of Common A, Redeemable Preferred A, Redeemable Preferred C shares for a total subscription price of P4.099 billion. ACEN said the subscription will be used by Giga Ace 8 to fund the proposed 300-megawatt-peak (MWp)/237-megawatt alternating current (MWac) Palauig Solar 2 project.

Does Ayala Group own Giga Ace 8?

The Ayala Group's listed energy platform said it signed an agreement with Giga Ace 8 Inc. for the subscription of 151.69 million shares to be issued out of the increase in authorized capital stock of the subsidiary.

What is Giga Ace 4 & Bataan solar energy doing?

Recently, the power company announced that it would infuse P2.2 billion into Bataan Solar Energy, Inc. and Giga Ace 4, Inc. to introduce new energy technologies. It also plans to expand ACE Endeavor's power generation operations to other areas within the country with a budget of up to P5 billion.

The Ayala Group's listed energy platform told the stock exchange that it signed a contract with Giga Ace 8 Inc. for the subscription of an aggregate of 321.88 million shares. Giga Ace 8 is ACEN's special purpose vehicle for the development of renewable energy projects in ...

Similarly, ACEN is subscribing to additional shares in Santa Cruz Solar Energy Inc., SolarAce2 Energy Corp., Gigasol1, Inc., Giga Ace 8, Inc., and Giga Ace 6, Inc. These subscriptions, totalling billions of pesos, aim to enhance the financial capacity of each SPV for their respective RE projects, including wind power and solar ventures.

Giga Ace 8 said the plant's output will primarily be generated from solar power during daylight hours, with any excess solar generation stored in the BESS for use in the event of an energy deficit.
