Where can I store precious metals in Liechtenstein?

OZL Offnes Zolllagerin Liechtenstein AG offers the possibility of individual safekeeping of precious metals in domestic storage at several certified locations in the Principality of Liechtenstein. In addition, there is also the possibility of safekeeping in the bonded warehouse (often also referred to as duty-free warehouse).

V SPG).

Does Liechtenstein comply with international standards?

Liechtenstein has committed itself again to a high standard of compliancewith international and european requirements in the area of fighting money laundering and terrorist financing.

Is Liechtenstein part of the EEA?

Liechtenstein is the only microstate (not counting Iceland by population) that is part of the EEA. Liechtenstein joined the EEA on 1 May 1995 after becoming a full member of the European Free Trade Association (EFTA) in 1991 (previously, it had participated in EFTA through Switzerland's membership).

When did Liechtenstein join the Schengen Area?

Liechtenstein signed a Schengen association agreement with the European Union on 28 February 2008, and originally planned to join the Schengen Area on 1 November 2009.
