Can you store lithium ion batteries in the UK?

The UK doesn't have specific regulations or legislation for the general storage of lithium-ion batteries. The Health and Safety Executive has, however, published guidance on good practices for handling and storing batteries, even though it is not compulsory. Regulations are not prescriptive but instead follow the typical routes:

Can lithium ion batteries be protected in storage?

That is where Article 320, Safety Requirements Related to Batteries and Battery Rooms comes in. Its electrical safety requirements, in addition to the rest of NFPA 70E, are for the practical safeguarding of employees while working with exposed stationary storage batteries that exceed 50 volts.

All batteries gradually self-discharge even when in storage. A Lithium Ion battery will self-discharge 5% in the first 24 hours after being charged and then 1-2% per month. If the battery is fitted with a safety circuit (and most are) this will contribute to a further 3% self-discharge per month.

Store lithium-ion batteries and products in cool, dry places and out of direct sunlight. Allow the lithium-ion battery to cool after use and before recharging. Buy replacement batteries from the original supplier or a reputable supplier where possible. Keep lithium-ion batteries separate from each other when removed from products. What not to do

The storage temperature range for Lithium Ion cells and batteries is -20°C to +60°C (-4°F to 140°F). The recommended storage temperature range is 0°C to 30°C (32°F to 86°F). At this storage temperature range, the battery will require a maintenance charge within a nine (9)

What are the storage requirements when not using Li-ion batteries? It is best to store Li-ion batteries at room temperature. There is no need to place them in the refrigerator. Avoid long periods of extreme cold or hot temperatures (e.g., dashboard of car in direct sunlight). Long periods of exposure to these temperatures can result in battery ...
