Does a lithium battery Mark have a UN number?

Yes. The mark may bear all applicable UN numbers, e.g. UN 3091, UN 3481, to identify that the package contains lithium metal batteries packed with or contained in equipment and lithium ion batteries packed with, or contained in equipment. What is a lithium battery?

Lithium Battery - The term "lithium battery" refers to a family of batteries with different chemistries, comprising many types of cathodes and electrolytes. For the purposes of the DGR they are separated into: Lithium metal batteries. Are generally primary (non-rechargeable) batteries that have lithium metal or lithium compounds as an anode.

What is a watt-hour lithium ion battery?

The Watt-hour (Wh) rating is a measure by which lithium ion batteries are regulated. Section I lithium ion batteries manufactured after 31 December 2011 and Section IB and Section II lithium ion batteries manufactured after 1 January 2009 are required to be marked with the Watt-hour rating on the outside case.

Does Pi 967 require a lithium battery Mark?

lithium battery mark is not requiredfor packages prepared in accordance with Section II of PI 967 or PI 970 containing only button cell batteries installed in equipment (including circuit boards) or consignments of two packages or less where each package contains no more than four cells,or two batteries installed in equipment.

Are lithium ion batteries regulated?

Shipping of lithium ion cells >60 WH and batteries >300 WH and lithium metal cells >5 grams lithium per cell and >25 grams per battery as fully regulated Class 9 hazardous materials. This includes Class 9 batteries that are "packed with" and "contained in" equipment. There is no general relief for larger batteries.

Understanding the difference between UN3480 and UN3481 is crucial for the safe transportation of lithium batteries. UN3480 refers to lithium-ion batteries shipped alone, while UN3481 pertains to lithium-ion batteries contained in or packed with equipment.
