What is the cost analysis of energy storage?

We categorise the cost analysis of energy storage into two groups based on the methodology used: while one solely estimates the cost of storage components or systems, the other additionally considers the charging cost, such as the levelised cost approaches.

What are the levelised cost approaches for energy storage?

The levelised cost approaches for energy storage include metrics such as the levelised cost of storage when electricity is discharged (LCOS) and LCOH or LCOM when hydrogen or methane are discharged, respectively [12, 22]. All the levelised cost metrics above are similarly structured.

## How much does energy storage cost?

Assuming N = 365 charging/discharging events, a 10-year useful life of the energy storage component, a 5% cost of capital, a 5% round-trip efficiency loss, and a battery storage capacity degradation rate of 1% annually, the corresponding levelized cost figures are LCOEC = 0.067 per kWhand LCOPC = 0.206 per kW for 2019.

Does storage reduce electricity cost?

Storage can reduce the cost of electricity for developing country economies while providing local and global environmental benefits. Lower storage costs increase both electricity cost savings and environmental benefits.

How can we discuss future electricity storage cost?

A new approach to discuss future electricity storage cost is introduced by McPherson et al. (2018), using the integrated assessment mode MESSAGE to include the uncertainties of VARET provision and abatement cost.

## What is the levelized cost of energy storage (LCOEs) metric?

The Levelized Cost of Energy Storage (LCOES) metric examined in this paper captures the unit cost of storing energy, subject to the system not charging, or discharging, power beyond its rated capacity at any point in time.
