#### What happened to Meng Wanzhou?

When her plane from Hong Kong landed, Meng Wanzhou planned to go to a house she owned in the Canadian city to collect some luggage before catching another flight to Mexico for a corporate meeting. But instead she was questioned by Canadian border security agents for three hours as her phone was seized and luggage searched.

#### Will Meng Wanzhou return to China if he admits wrongdoing?

The Justice Department reached an agreement on Friday that clears the way for Huawei Technologies' chief financial officer, Meng Wanzhou, to return to China in exchange for admitting wrongdoing in a fraud case.

## Why did Huawei's Meng Wanzhou fly to Shenzhen?

Huawei's Meng Wanzhou flew to Shenzhen on Saturday evening, hours after two Canadians freed by China had gone back. In 2018 China accused Michael Spavor and Michael Kovrig of espionage, denying detaining them was in retaliation for Ms Meng's arrest. The apparent swap brings to an end a damaging diplomatic row between Beijing and the West.
